TERMS AND CONDITIONS - DOG WALKING

Daily dog walking consists of 30, 60 or 90 minute visits. The walk will not include travel time. In the event of extreme weather conditions for example high temperatures, heavy snow or pet injury/illness (*or at the clients request*), the dog will be given time in the garden/yard to relieve him/herself. The rest of the time will be spent indoors with client approved activities.

CLIENT AUTHORISATION

- 1) I agree to provide keys to Leading the Field for the dog walking/sitting appointment.
- 2) I agree that the information given to Leading the Field regarding my dog's behaviour and past history is accurate and up to date.
- 3) I authorise Leading the Field to obtain any emergency veterinary care that may be necessary during the time spent with my pet. Every effort will be made to contact the owner prior to seeking emergency care.
- 4) I accept responsibility for any charges related to this emergency care. I also authorise Leading the Field to use an alternative veterinarian in the event my usual vet is unavailable.
- 5) I agree to reimburse Leading the Field for any additional fees for providing veterinary care as well as any expenses incurred for food, supplies or unexpected emergency home visits.
- 6) I agree to notify Leading the Field of any complaints or concerns within 24 hours of any appointment.
- 7) I agree to give 24 hours' notice to cancel any appointments or agree to pay Leading the Field the full amount for the agreed appointment.

LEADING THE FIELD DUTY OF CARE

- 1) Leading the Field agrees to provide the services stated in this agreement in a reliable, honest and caring way.
- 2) Leading the Field will not let any dog off lead unless express owner consent has been given and signed for.
- 3) During all assignments pet care will only be undertaken by Leading the Fields owner or employees who are fully insured and police checked.
- 4) In the event of an incident whereby a pet needs emergency veterinary care Leading the Field agrees to seek this care without delay and remain with the pet until the owner arrives. In the event a pet gets lost every effort will be made to locate them as soon as possible.
- 5) Leading the Field agrees to communicate to the client any concerns regarding the dog's behaviour as soon as possible.
- 6) Leading the Field agrees to give your pet lots of love and care in your absence.

This agreement is valid for all future visits. Leading the Field has the right to terminate this agreement at any time at its sole discretion. Likewise, the owner has the right to terminate this agreement. There is no notice period.

Permission to walk dog off lead:

The client is aware and agrees that the clients dog/s may be off lead in designated and safe areas away from roads in order to provide maximum exercise and play. Leading The Field reserve the right to keep the clients dog/s on a lead should they feel that the dog/s recall is not sufficient to maintain safety and control. The client agrees that should the dog/s run away or be injured during the off leash exercise Leading The Field will not be held responsible, however every assistance will be provided to locate dog/s.
